Regulations

These regulations (the **Regulations**) govern the competition "UNA...World Cup Offer", promoted by UNA Hotels & Resorts (the **Competition**) and related to the scores of the official matches (the **Matches**) of the 2010 FIFA South African World Cup (the **World Cup**).

When

The Competition shall be effective from the date of its publication **until 10 July 2010**.

Who

The requirements for entering the Competition (the **Competition Requirements**) are the following:

- make a reservation (the **Reservation**) for a stay (the **Stay**) at one of UNA Hotels & Resorts (the **Hotel**) through its websites www.unahotels.it or www.unawayhotels.it (the **Websites**) by **10 July 2010**;
- the Stay shall include one or more consecutive days falling, whether in whole or in part, **between 11 June 2010 and 11 July 2010** included.

How

Customers accessing the Websites to reserve a Stay according to the Requirements shall be allowed to choose among a special rates for the Competition (the **UNA World Cup Offer**) and one or more other rates (the **Other Rates**) by 10 July 2010.

Customers choosing the UNA World Cup Offer shall enter the Competition and accept its Regulations.

Customers choosing one of the Other Fees shall not enter the Competition.

Upon Reservation of their Stay, Customers entering the Competition shall be asked to **predict the final score for a Match of the World Cup** (e.g., Team A : Team B = 3 : 1), choosing among those which will be played during their Stay (the **Prediction**). The Prediction shall be written in the "comments" field of the Reservation form. "**Final score on the field**" means the score at the end of the 90 minutes regulation time or any extra time, excluding the following penalties phase.

If the Stay falls, in whole or in part, after 25 June 2010 – hence in the final period of the World Cup – and the teams participating therein are not known upon Reservation, the Match may be chosen and the Prediction may be made before check-in at the Hotel or before the team names are made public, whichever occurs first.

Predictions shall in no event be made after the beginning of the Match to which they refer.

If a Prediction turns out to be correct (e.g., the final score for the Match Team A : Team B is actually 3 : 1), Customers shall be granted a reduction (the **Reduction**) equal to 50 % of the amount due for their Stay as calculated upon Reservation (the **Reservation Amount**). The Reduction shall only apply to the on line Reservation amount and not, without limitation, to costs and expenses incurred or to be incurred for any services used in the Hotel (food and drinks, minibar, laundry, telephone, pay-tv, etc.) or for any nights additional to those specified upon Reservation.

Winnings shall only entitle to the Reduction and may not be converted into cash, used for reservations other than the Reservation for the Stay or transferred to third parties.

Loss of the right to enter the Competition

Customers shall lose their right to enter the Competition (without any entitlement to indemnities, compensation or refund) in the following events:

- non compliance with the Regulations (e.g. if Customers quote Matches which are not played during the Stay and make more than one Predictions);
- no-show;
- cancellation (in whole or in part) of the Reservation to which the Competition is connected;
- if the Match to which the Prediction refers is not played or ends before any score is reached;
- if Customers leave the Hotel before the time they specified upon Reservation and the Match to which their Prediction is referred is played after their departure(*)).

(*) If the Match is played before the date of the early departure, Customers will take part to enter the Competition anyway but, in case of winnings, the Reduction shall apply pro quota to the price of the Stay actually paid and not to the price calculated upon Reservation.
